Delta College Police Academy Margaret Mosqueda, Vice President of Student and Educational Services introduced Chief Robert Battinkoff.

Chief Battinkoff introduced Mike Goodall, Coordinator of the Delta College Police Academy, and Haylee Porterfield, recent Police Academy Graduate.

M. Goodall said that Delta College has had a 52 year tradition of having a police academy. The 104th class just started this winter. The academy is 17 weeks long. This winter, 17 students are enrolled. He reviewed the requirements and curriculum of the academy. He noted that MCOLES requires 594 hours. The Delta College Police Academy provides students with an additional 150 hours of instruction.

M. Goodall said that Delta's Police Academy graduates have a high success rate in finding job placement.
